## ORDINANCE # 080696

### **An ordinance to create a planning commission for the Town of Vance.**

BE IT ORDAINED by the Council of the Town of Vance , Alabama as follows:

1. That, there is hereby created, a planning commission for the town to consist of nine (9) members to be appointed for terms and in the manner set forth in the Code of Alabama (1975) SS 11-52-3 to 11-52-5.

2. That, the planning commission is hereby authorized and empowered to exercise all powers and do all things authorized to such a commission by Title 11, Chapter 52, of the Code of Alabama, as it may deem necessary for its work.

3. That, the planning commission is authorized and empowered to make and adopt a master plan for the physical development of the town including any areas outside its boundaries which, in the commission's judgment, bear relation to the planning of the town. Such plan, with the accompanying maps, plats, charts and description matter, shall show the commission's recommendations for the development of such territory, including, among other things, the general location, character, and extent of streets viaducts, subways, bridges, waterways, waterfronts, boulevards, parkways, playgrounds, squares, parks, aviation fields, and other public ways, grounds and open spaces, the general location of public buildings and other public property, general location and extent of public utilities and terminals, whether publicly or privately owned or operated, for water, light, transportation, sanitation, communication, power, and other purposes; also the removal, relocation, widening, narrowing, vacating, abandonment, change of use or extension of any of any of the foregoing ways, grounds, open spaces or extension of any of the foregoing ways, grounds, open spaces, buildings, property, utilities, terminals; as well as a zoning plan for the control of the height, area, bulk, location, and use of the buildings and premises.

4. That, as the work of making the whole master plan referred to in paragraph 3 progresses, the planning commission may from time to time adopt and publish a part of parts thereof, any such part to cover one or more major sections or divisions of the city or one or more of the matters mentioned in paragraph 3 or other functional matters to be including in the plan.

5. That, the planning commission is also authorized and empowered to exercise all powers and to do all things authorized to such commission by Title 11, Chapter 52, of the Code of Alabama, and to exercise such control as is authorized thereunder with reference to subdivisions of unimproved property within five (5) miles of the corporate limits of the town as per Ss 11-52-39 of the Code of Alabama (1975).

That, the governing body and it's head are hereby authorized to make all appointments and exercise all authority with respect to the planning commission as is authorized by Title 11, Chapter 52, of the Code of Alabama.

This Ordinance shall become effective upon its adoption and posting.




*Woodstock corridor Annexation*

**An ordinance to increase the compensation of the Mayor of Vance, Alabama beginning in the 1996 term.**


BE IT ORDAINED by the Council of the Town of Vance, Alabama as follows:

1. That, pursuant to s11-43-80, Code of Alabama, 1975, the Mayor of the Town of Vance, Alabama shall be compensated for his services to the town, beginning in the 1996 mayorial term, as follows:


- A. By payment of a salary of \$500.00 per month.
- B. Per diem compensation of \$85.00 per day for every day or a prorated amount for less than full days.
- C. Expenses as approved by the Council and where receipts are provided
- D. Medical insurance is to be provided to the Mayor at the Towns expense and the Mayor may have the option to purchase family coverage under the insurance policy at his expense.


